How to include Bruce Peninsula Hospice in your will

Naming Bruce Peninsula Hospice as a beneficiary in your Will is one of the simplest ways to support Bruce Peninsula Hospice.

To name Bruce Peninsula Hospice as a beneficiary in your Will, please note our legal name is: **Bruce Peninsula Hospice Inc.** and include our address: 369 Mary Street, Warton, Ontario N0H 2T0 and Charitable Registration Number: 82244 9526 RR0001.

Sample Clauses *(Please speak to your legal advisor about drafting or revising your Will.)*

1. Specific Bequest (a gift of a specific amount or asset)

I give to Bruce Peninsula Hospice Inc. currently located at 369 Mary Street, Warton, Ontario N0H 2T0, the sum of _____ Dollars \$_____ to be used for its general purposes.

2. Residual Bequest (a share of the remainder of your estate after other needs are met)

I give to Bruce Peninsula Hospice Inc. currently located at 369 Mary Street, Warton, Ontario N0H 2T0, _____% of the residue of my estate to be used for its general purposes.

What if I already have a Will?

If you have an existing Will, but would like to include a gift to Bruce Peninsula Hospice, you can make a codicil, which is supplementary to your Will and can make simple changes or addition to it. We recommend that you see your lawyer/legal advisor when making a codicil, so they can advise you about the process and draft the codicil correctly.

Benefits of Making a Gift in your Will to Bruce Peninsula Hospice

- Your assets remain in your control during your lifetime.
- You can change your gift in your Will if your circumstances change.
- Your gift can be made for any amount.
- A gift in your Will is an effective way to reduce estate taxes. There is no upper limit on the estate tax deductions that can be taken for charitable bequests.
- Bruce Peninsula Hospice Inc. will issue an official receipt for the full value of the bequest.
- You know that your gift will greatly benefit the individuals and families Bruce Peninsula Hospice will assist in the future.
